**Sub: Violation of Sindh Public Procurement Rules 2010, PSP, Superintendent of Police,
Kashmore at Kandhkot's Tender Notice for Procurement of the Work.**

Dear Sir,

This is with reference to Police Department, Kashmore at Kandhkot's Tender Notice published in daily "Dawn" on 4th March, 2018. It is observed that the advertisement is in violation of the Sindh Public Procurement Rules 2010.

As per advertisement, the bid receiving date is given as 19-03-2018, while the bid opening date is on 22-03-2018. It is a violation of SPPRA 2010, Rule 41(1). Stated as under;

41. Opening of Bids: - (1) The date for opening of bids and the last date for the submission of bids shall be the same, as given in the bidding documents and in the Notice Inviting Tender;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 32(A), and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
