Transparency International Pakistan has received a complaint against National Institute of Cardiovascular Diseases for Unfair practices in Procurement for Installation of CCTV Surveillance System in Tender 49/2016 dated 20-4-16 from M/s Electronic Safety & Security Private Limited dated 4<sup>th</sup> May, 2017.

The complainant has alleged that;

1. Complainant took part in the above said tender. The bid was opened by a non-technical management staff, on the day of opening of technical proposal, and the bids were rejected of the top installation companies including complainants due to a form which NICD wanted on the same paper which was provided in the tender document.
2. That designed paper was not enough in size to provide proper details asked by the company.
3. So the complainant has attached all the required answers on separate paper along with details of each and every product.
4. The same form was similarly customized by the three other rejected bidders.
5. Such kind of unfair practice shows the polarity of the department towards any specific vendor that may be due to favoritism, pre decided settings, or may be kickbacks.

ED, NICD is requested to kindly examine the complaint, and investigate the process, and if found genuine take necessary action against all those officers involved in corrupt.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
