SUBJECT: - VIOLATION OF SINDH PUBLIC PROCUREMENT RULES 2010, ADMINISTRATOR DISTRICT MUNICIPAL CORPORATION KARACHI TENDER NOTICE FOR P/L PIPE DRAIN & RECONSTRUCTION WORKS.

Reference: Your Letter TL15/229/5A, dated 22-09-2015 received in this office on 28-09-2015.

This office appreciates your gesture regarding tender notice published in daily Dawn on 19th September 2015 (copy of press clipping is attached at Annexure-"A"). In this regard, it is clarified that no violation is committed by this office. The supporting arguments are as under:-

As Rule 18 and sub rule-3, of SPPRA Rules 2010 say that procuring agency shall ensure that bidding document are available to the interested bidders from the first day of Notice inviting tenders in newspaper or *hoisting on the website as the case may be so,*

1. As you are well aware under Rule-17 and its Sub-Rule (3) advertisement for notice inviting tender shall appear in at least three widely circulated leading dailies of English, Urdu, and Sindhi languages. In the wake of this rule, this office forwarded the request for publication of our NIT on 14th September 2015. Ordinarily the Information Department of Government of Sindh takes 5-7 days time for processing such requests. For that matter the time was kept on mind as well as the anticipated Eid-ul-Azha holidays, so a time slot for making the bidding documents available from the offices was scheduled as 28th September 2015 to 14th October 2015.

2. The request for hoisting our NIT was also sent to SPPRA and you may refer to the print out of our hoisted NIT on SPPRA Website, where the complete bidding documents were clearly available to be downloaded from this website to the interested bidders. It can be seen at Serial No. 25329. So this office was mindful of the prevailing rule that bidding documents were available to the interested bidders to be downloaded (print out is attached as Annexure-"B").
3. As our NIT was sent to the Information Department, Government of Sindh for publication on 14-09-2015 (receiving copy is attached as Annexure-"C"). Keeping in view seven days of processing time period required by Information Department, Government of Sindh and four days expected holidays of Eid-ul-Azha, the schedule for issuance of and closing was calculated / determined with the gap of 12 to 13 days from date of issue of NIT. The NIT was issued on 14-09-2015 and schedule for issuance closing of bidding documents was inserted with the gap of 13 days from the date of issue of NIT, i.e. 14-09-2015 and schedule for starting and closing of bidding documents is 28-09-2015 to 14-10-2015.

As the whole situating is clarified above, so your observation communicated to this office may be set aside and withdrawn in letter and spirit under intimation to this office at an earliest.
