Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Medical Superintendent, DHQ Hospital, Haripur's Re-Tender Notice for Procurement of Bio-Medical Equipment.

Dear Sir,

This is with reference to DHQ Hospital, Haripur's Re-Tender Notice published in daily "Mashriq" on 30th March, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, "The quantity may be increased/decreased according to the quoted price/budget", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:

(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:

(i) repeat orders within a period of six months:

Provided that it does not exceed fifteen percent of the original contract value;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

The Medical Superintended invites sealed bids from the eligible bidders for supply of equipments, Instruments, etc to meet the requirement for the up-gradation of Dialysis Unit DHQ Teaching Hospital Haripur during the current financial year 2017-18 under Single Stage – Two envelope bidding method as per rule 40 of the KPK Procurement of Goods, Works and Services Rules 2014. Detailed specifications and quantities of Bio Medical Equipments, Instruments, for up-gradation of Dialysis unit are included in the Standard Bidding Documents.
2. Interested eligible, pre-qualified bidders may obtain a complete set of Original Bidding Documents on payment, printing, stationary charges (non-refundable) on their written request from the office of the undersigned on any working day during office hours or the same can be examined on the website of DHQ Teaching Hospital Haripur until the closing date.
3. A pre-bidding meeting shall be held at the office of the undersigned on **07.04.2018 at 11:00AM**. The bidders are requested to thoroughly study the Standard Bidding Documents before the pre-bidding meeting for any clarification of their queries during the said meeting.
4. Bids must be delivered at the address given below through courier/registered post, on **19.04.2018** at or before 12:00Noon and the technical bids only shall be opened on same day at 12:30PM in the presence of bidders or their authorized representatives if they so desire.
5. Financial bids must be accompanied with a **Bid Security / Earnest Money** which is 2% of the total bid value National and International Manufactures and Authorized/Sole agents registered with Directorate General Health Services Khyber Pakhtunkhwa in the form of a **Pay Order/ Bank Draft/Call Deposit** in favor of Medical Superintendent DHQ Teaching Hospital, Haripur.
6. An affidavit to the effect that call deposit/bank draft is attached with the financial proposal, otherwise the technical proposal shall be considered non-responsive.
7. The bidders are requested to give their best and final price of the quoted Equipments etc as per the specifications of the Standard Bidding Documents as no negotiations on the price is allowed and the quantity may be increased/decreased according to the quoted price/budget. The bid shall be valid up to 30.06.2018.
8. The competent authority has the right to reject any or all bids by assigning reason under Rule 47 of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Service Rules, 2014.
9. For all the electrical operated equipment either the design should be clear enough to compensate for low voltage functions are should have built in /external AVR system for smooth running of equipments.
10. The firm concern will be responsible for providing technical manual / circuit diagram and training to the end users and bio medical engineer of electro medical workshop.
11. The selection will be made on quality of sample along with the given specification.
