**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and
Services Rules 2014, Regional Sports Officer, Office of Regional Sports Officer, Swat's
Tender Notices for Purchase of Miscellaneous Items.**

This is with reference to Office of Regional Sports Officer, Swat's Tender Notice, published in daily "The Nation" on 27th March, 2019. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

As per terms and condition No. 11 in the advertisement, "The quantity of the items can be changed based on availability of funds", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPPRA Rules 2014, No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:


(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:

(i) repeat orders within a period of six months:

Provided that it does not exceed fifteen percent of the original contract value;

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERM AND CONDITIONS:-

1. The bids documents can be obtained from Regional Sports Officer in any working day during office hours.
2. Each bid should be sealed and properly stamped.
3. No secured advance or advance payment whatsoever shall be payable to the supplier.
4. Contracting firms must be tax registered with FBR in withholding tax as well as Sales tax and visible on Active Tax payer list (Both NTN & STRN). All applicable taxes will be deducted as per Government rules. Suppliers must invariably mention that the rates are inclusive of taxes.
5. Sealed bid must be accompanied by a bid security for an amount not less than 2% (two percent) of the total tender value (refundable) in the form of Call deposit Receipt (CDR) Bank Draft from the account of firm / bidder / contractor who submits the bid issued by any schedule Bank of Pakistan in the name of Director General, Sports & Youth Affairs, Government of Khyber Pakhtunkhwa to be valid for 180 days (one hundred and eighty days).
6. Tenders will be received manually and will be dropped in tender box as per schedule given above. The bids will be opened on 08-04-2019 at 11.30 AM.
7. Samples must be produced at the time of opening of tender.
8. The bidder shall furnish an affidavit on Rs 100/- Stamp paper to the effect that the firm is not black listed in any Government Department and no suit with any purchaser is pending in any court of law.
9. The purchase committee reserves the right to cancel one or all bids under Rule 47 (1) of KPPRA Rules 2014 and reasons for rejection will be furnished on the demand of the bidder
10. Conditional, incomplete, unsigned and bid filled with led pencil will not be accepted.
11. Quantity of the items can be changed based on availability of funds.
