**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director (Operations), Directorate General of Sports, Peshawar Cantt's Tender Notice for Procurement of Professional Gym and Fitness Equipment.**

This is with reference to Directorate General of Sports, Peshawar Cantt's Tender Notice, published in daily "Aaj" on 28<sup>th</sup> April, 2019. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per terms and condition No. 10 in the advertisement, "The quantity of the items can be increased or decrease depending on the available budget", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

***10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:***

***(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:***

***(i) repeat orders within a period of six months:***

***Provided that it does not exceed fifteen percent of the original contract value;***

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

## TERMS AND CONDITIONS

1. Both Envelopes should be separately and clearly marked as " Technical Proposal and Financial Proposal" and placed in single sealed envelope. 2. Bid schedule to the tender can be obtained from the office of DG Sports Khyber Pakhtunkhwa, Peshawar Sports Complex, Peshawar Cantt on any working day before opening of the tender. The tender documents pertaining to the above items can be obtained at a cost of Rs. 1000/- (Nonrefundable) from the office of undersigned on submission of an application on the original letter head of the firm on any working day during office hours. 3. Each bid should be sealed and properly stamped. 4. Sealed bid must be accompanied by a bid security (attached with financial bid) for an amount not less than 2% (two percent) of the total tender value) (refundable) in the form of Call deposit Receipt (CDR) / Bank Draft issued by any schedule Bank of Pakistan in the name of Director General Sports, Government of Khyber Pakhtunkhwa to be valid for 180 days (one hundred eighty days). 5. No secured advance or advance payment whatsoever shall be payable to the supplier. 6. Contracting firms must be tax registered with FBR in withholding tax as well as Sales tax and visible on Active Tax payer list ( Both NTN & STRN). All applicable taxes will be deducted as per Government rules. Suppliers must invariably mention that the rates are inclusive of all taxes. 7. Tenders will be received manually and will be dropped in tender box as per schedule given above. The technical bids will be opened on the same day at 2:30 PM. 8. Tenders will be opened in the presence of the interested bidders or their representatives on the date and time mentioned below at Peshawar Sports Complex, Peshawar Cantt. 9. Financial bid will be opened later and call notice to the successful bidders will be sent accordingly. 10. The quantity of items can be increased or decreased depending on the available budget. 11.
