

Tender forms could be received from the Office of the Principal, GDC, Tajori Lakki Marwat by the firms or their authorized representatives during office hours. Photo copy of the tender forms and the forms not signed by the undersigned will not be accepted.

Terms and conditions are as follows:-

1. (2%) two percent call deposit of the total amount (refundable) shall be attached with the tender form.
2. Each demand will be sent in separate envelope and may be written on the corner of envelope.
