**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services
Rules 2014, Assistant Director, LG & RDD, Khyber Tribal District's Tender Notice for
Solarization and Solar Street Light Works.**

This is with reference to LG & RDD, Khyber Tribal District's Tender Notice published in daily "Aaj" on 4th Dec, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 14-12-2018, which is 4 days short. It is a violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

 - CNIC Photo copy.
- Tender form shall be issued as mentioned above and no tender form will be issued on the opening date.
- Tender form for the scheme will be issued only to the firms/contractors notified/qualified by FATA secretariat for Solarization for the financial year 2018-19. All taxes will be deducted as per Govt. policy.
- Tender will be received at 11:00 am on the 1st opening date of tender and will be opened on the same date in the presence of contractors or their authorized representatives at 12:00 Noon.
- Tender will be received at 01:00 pm on 2nd and 3rd opening date of tender and will be opened on the same date in the presence of contractors or their authorized representatives at 2:00 pm.
- Call deposit of the 2nd and 3rd lowest bidder will be retained till approval of the tender.
- The tender documents must be signed by an authorized person of the firm / contractor.
- Tender form will be issued to contractor/firm in person or their representatives having power of attorney.
- Governor Khyber Pakhtunkhwa order No.FV-53/750-35 Dated 18-3-2014 will be implemented in tendering process.
- The rate quoted by the contractor more than 10% below on estimated cost will be rejected.
- If the lowest bid costs of two or more than two bidders are same then the successful bid will be declared through draw in the presence of bidders.
- The bidders who quoted rate 10% below on BOQ/Engineer's estimate money within 3-days of the opening of tenders, otherwise they will be kept out of tender process and their call deposit (2% earnest money) will be forfeited.
- Any disfiguring/over writing, manipulation in the tender shall be liable to rejection.
- In case a Public Holiday is announced by the Govt. (due to any reason) the tender will be opened the next working day at the same time and venue.
- The undersigned reserves the right of rejection /approval one or all the tender under the rules.
