Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, TMO/ Tehsil Officer (I&S), Tehsil Municipal Administration (TMA), District Haripur's Tender Notice for Miscellaneous Works.

This is with reference to TMA, District Haripur's Tender Notice, published in daily "Nai Baat" on 4th Nov, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, no response time is mentioned for the submission/ opening of bids for the bidders. It is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Any contractor/firm are bound to mention the rates as per notification No KPPRA/M&E/Esit:1- 5/2016" Above/Below System". 5. The contractors / bidders who offer / Quote their bids / rates more than 10% below the Engineer's Estimate shall submit an additional security in the form of call deposit equal to 8% of the estimated cost. After commencements of work by the successful bidder 8% call deposit may be replaced with a bank guarantee of the same amount from the schedule bank". 6. The downloaded BOQ & calls deposit must be attached along with tender form, if any negligence from the contractor in this matter, the department can debar such contractor from E-Tendering system. 7. In case bids become tie, the award of contract shall be decided through a free -toss which shall tie binding and final. 8. All Federal and Provincial duties /stamp duty and taxes including sales tax will be recoverable as per directives of the Government issued from time to time. 9.
