**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods,
Works and Services Rules 2014, Assistant Engineer/ Assistant Director (S),
LG & RDD, Swat's Tender Notice for Construction Works.**

This is with reference to LG & RDD, Swat's Tender Notice, published in daily "Aaj" on 6th Dec. 2018. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

As per the advertisement, the tender submission date is given as 27-12-2018, while the tender opening date is given as 17-12-2018. Therefore, the advertisement is in violation of KPPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- The contractor who offered their bids online but do not sent the hard copies of incomplete/defective documents, will be debarred from tendering process of Directorate blacklisting.
- The contractors are required to fill the tender form and BOQ online and submit a hard copy of the same later to the office of AD(S) LG&RDD Swat. The original and duplicate copies of tendered documents clearly marked as original and duplicate in the name of concerned VC/NC Nazim and Assistant Director (S) LG&RDD Swat respectively (sealed in one envelope) must be submitted to office of the Assistant Director (S) LG&RDD Swat. The Tender documents must reach this office up to fixed date and time as mentioned.
- The following documents must be attached with the bids.
 - Enlisted and renewal copy in LG&RDD for the year 2018-19
 - Photocopy of CNIC.
 - Power of authority (if applicable)
 - Pakistan Engineering Council (PEC)
