Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Nazim/Tehsil Municipal Officer (TMO) Tehsil Municipal Administration (TMA), Lachi's E-Tender Notice for Miscellaneous Works.

Dear Sir,

This is with reference to TMA, Lachi's E-Tender Notice, published in daily "Aaj" on 9<sup>th</sup> February, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per the advertisement, "Competent Authority reserves can reject/cancel any one or all of the tender without assigning any reason." Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.47 (1) that requires the reason to be communicated to the bidders. Stated as under;

*47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.
