Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Municipal Officer/ Tehsil Nazim, Tehsil Municipal Administration, Chakdara town, Lower Dir District's Tender Notice for Purchase of Item.

Dear Sir,

This is with reference to TMA, Chakdara town, Lower Dir District's Tender Notice published in daily "Mashriq" on 9<sup>th</sup> October, 2017. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

- 1. As per the advertisement, 15 days of response time is not given and the last date for submission/ opening of bids is given on 19-10-2017, which is 4 days short. It is a violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:
  - 34. Response time.—(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.
- 2. Also, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPPRA Rules 2014, Rule No.33 (5). Stated as under:
  - 33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.



The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
