Dear Sir,

This is with reference to Village Council Saidra Jewar, Tehsil Dargai, District Malakand's E-Tender Notice, published in daily "Mashriq" on 9th October, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of bids is on 19-10-2017, which is 4 days short and is violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Terms & Conditions.

- Tender form/BOQ can be downloaded by the original contractor available on LG&RDD web site(www.lgkp.gov.pk) after publication.
- The sealed tenders should reach to the office of Undersigned on or before the opening date/time given against each work.
- The tender documents should be complete in all respect and incomplete documents will not be acceptable for consideration.
- The following documents are required to be submitted with the application/tender form:
 - Earnest money to the extent of 2% in the shape of deposit at call in the name of Concerned Nazim along with stamp duty.
 - Enlistment copy and renewal with LG&RDD for the current year.
 - CNIC copy of the bidder.
 - Copy of registration and renewal of Pakistan Engineering Council for the current year.
- Bidders found with bogus documents, their tenders will be rejected and their cases will also be forwarded to higher ups for black listing.
- The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring entity shall upon request communicate to any contractor or consultant who submitted a bid or proposal, the ground for rejection of all bids or proposals.
- All the government taxes will be deducted as per prevailing government policy.
- The tender shall be processed according to "Above/Below system on BOQ based on MRS applicable.
- Any cutting/overwriting on the BOQ will be liable to rejection of the tender and will be declared defective.
- Tenders/bids should reach the office of the undersigned through courier/registered post before the opening time.
- Responsibility of late delivery will not rest upon this office.
- The duplicate copy of sealed tender must be sent to concerned Assistant Director LG&RDD office for record purpose before the closing date and time of the tender.

- The contractors/bidders who quote their bids/rates more than 10% below the engineering estimate shall submit an additional security in the form of call deposit equal to 8% of the bid cost, if failed the second lowest bidder and so on will be considered accordingly.
