Sub: Violation of Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act 2012,
Director Works, Shaheed Benazir Bhutto Women University, Peshawar's Pre-Qualification
Notice for Civil Works/Building Works.

Dear Sir,

This is with reference to SBBWU, Peshawar's Pre-Qualification Notice published in daily "Mashriq" on 10th September, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement Regulatory Authority Act 2012.


As per the advertisement, after scrutiny the Pre-Qualified contractors/ firms will have to issue the tender document on written application to the Director SBBWU, Peshawar, with pay order of PRs 15,000 (non-refundable), which appears costly in light of the Procurement Act and is violation of KPK PPRA Act 2012. According to the Act, Section No. 19, in the 'Public Accessibility' Clause, the tender document fee shall not exceed printing cost. The Section is quoted below for your reference;

19. Public Accessibility. --This Act, the rules made thereunder, guidelines, forms, bidding documents and/or decisions of Government or procuring entity relating to procurement shall be placed on a web-site of the Authority in addition to the website of the procuring entity or the Government, as the case may be, and which will also provide copies of these documents to the public at a fee not exceeding the cost of printing/reproduction of the documents.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

12. Those who fail to provide the above mentioned documents shall be disqualified.
13. Last Date for submission of pre-Qualification documents is **27th Sep, 2016**.

After scrutiny, the Pre-Qualified contractors/firms will have to issue the tender documents on written application to the Director Works Shaheed Benazir Bhutto Women University Peshawar, with Pay orders of Rs, 15,000/- (Rupees fifteen Thousand only) in the form of the bank draft in favor of Treasurer, Shaheed Benazir Bhutto Women University Peshawar (non-refundable) up to 3rd Oct, 2016.
