Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Superintendent, Subjail Dassu, Kohistan's Tender Notice for the Supply of Cooked Food/ Cooked tea, Other Miscellaneous Articles and Medicines.

This is with reference to Subjail Dassu, Kohistan's Tender Notice, published in daily "Dawn" on 6th April, 2019. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, the tender submission date is given as 25-04-2019, while the tender opening date is on 26-04-2019. Therefore, the advertisement is in violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) *All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Sealed tenders for the supply of cooked food/cooked tea, other miscellaneous articles & medicines for Subjail Dassu, Kohistan are invited from the registered / pre-qualified contractors / firms of Khyber Pakhtunkhwa Prisons Department & Health Authorities Khyber Pakhtunkhwa for the financial year 2019-2020.

Tender forms along with prescribed schedule of the required items / articles can be obtained from the office of the superintendent Sub Jail Dassu, Kohistan on or before 25-04-2019 on any working day during office hours (except holidays) on cash payment of Rs. 1000/- (One thousand only) non-refundable. Moreover, the same tenders can be downloaded from the official website of public Procurement Regulatory Authority (www.kppra.gov.pk).

1. Tender forms along with schedule of required items (duly completed) in sealed envelope should reach in this office by 25-04-2019 till 10:00 a.m in the presence of concerned contractors / their authorized representatives, who opt to be present before committee members in the office of the undersigned.
2. The concerned firms / contractors will submit registration certificates with Health Department and Prisons Department, copy of Income Tax certificate is as well as earnest money to the tune of Rs One Lac in the form of call deposit in the name of Superintendent Subjail Dassu, Kohistan, at the time of collection of Tender Forms. In the absence of earnest money no tender form will be issued.
3. Income tax / sales tax / professional tax / stamp duty etc and any other tax levied by the government will be deducted from the bills of the contractors / suppliers in accordance with rules/policy.
4. In case of failure in supply or supply of substandard items or failure to abide by the rules, terms and conditions of the contract. Risk purchase shall be made & the difference will be met from his bill / earnest money, besides he will be blacklisted & his earnest money / security will be forfeited to the state as well as the fine can also be imposed.
5. Required items will be supplied to the Subjail Dassu, Kohistan during the financial year 2019-2020 at the main gate of jail.
6. Final approval of the contract for supply of the required items offered by the contractors/firms on the recommendation of purchase committee will be accorded by the Inspector General of Prisons Khyber Pakhtunkhwa, Peshawar, who is also authorized to reject any tender (partially / fully) after assigning reasons thereof.
7. In case of unscheduled public holiday or for some other reason, the Tenders shall be opened on the next day i.e 26/04/2019.
