
12. Bid security.---(1) *The procuring entity may require the bidders to furnish bid security of up to two per cent in case of procurement of goods, if required.*
(2) *In cases, where procurement is of complex nature, bid security up to 5 percent can be applied.*

This procurement is not of a complex nature.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
