Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Medical Superintendent, Shaheed Fareed Khan Hospital, Hangu's Quotation Notice for Canteen.

Dear Sir,

This is with reference to Shaheed Fareed Khan Hospital, Hangu's Quotation Notice, published in daily "Aaj" on 7th July, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, Shaheed Fareed Khan Hospital reserves the right to postpone or cancel quotation without assigning any reasons". It is not complying with KPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.
