**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Principal, Gajju Khan Medical College Swabi, Swabi's Tender Notice for Purchase of Medical Equipment and Instruments.**

Dear Sir,

This is with reference to Gajju Khan Medical College Swabi, Swabi's Tender Notice published in daily "Mashriq" on 9<sup>th</sup> May, 2017. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for submission of bids is given on 19-05-2017, which is 4 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

*34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Bids must be delivered at the address given below on or before **11.00 hours on 19/05/2017** (on the next day in case of gazetted holiday(s)) and shall be opened in the presence of the bidders or their authorized representatives, who choose to attend at the address below at 11:30 hours on the same date.

Firms, shall submit the Bid Security in an envelope along with the financial bids in the shape of Pay Order (PO)/Demand Draft (DD)/Call Deposit Receipt (CDR) equal to 2% of their bid amount in the name of Principal Gajju Khan Medical College Swabi. The bidders shall submit an undertaking in their Technical Bids that the requisite Bid Security is included in their Financial Bid. Late bids will be treated as non-responsive.
6. The Bidders are requested to give their best and final price for the quoted equipment as per the Specifications as no negotiations on the price are allowed. The bid must be valid up to 120 days from the date of opening of the bid.
