Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Municipal Officer (TMO)/ Tehsil Officer (Infrastructure), Tehsil Municipal Administration (TMA), Daggar Buner's Tender Notice for Installation of Solar Lights.

Dear Sir,

This is with reference to TMA, Daggar Buner's Tender Notice, published in daily "Mashriq" on 9th April, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, "the competent authority reserves the right to reject any or all the tenders without assigning any reason thereof". Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.47 (1). Stated as under;

47. Rejection of bids:- (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS AND CONDITIONS:

- Tender form can be downloaded from the date of appearance of the advertisement in the press next day from the official website of LG&RDD (LCB) Khyber Pakhtunkhwa (www.lgkp.gov.pk).
- The eligible contractors/firms are required to submit two separate envelopes i.e. one envelope containing technical information of the contractors/firm clearly marked as "Technical Bid" while the second envelope containing bid price, clearly marked as "Financial Bid", shall be accompanied with earnest money/Bid security @ 2% of the Bid cost in favor of Tehsil Municipal Officer, Daggar (Buner) from any scheduled bank of Pakistan.
- Attested Photocopies of the requisite documents like Enlistment, Pakistan Engineering Council registration and Income Tax certificate etc. must be attached with the application. (Original documents will be produced for confirmation on demand).
- Bidding shall be carried out on "Item rate basis". Wherein the Bidder are required to fill their own rates/amount in the blank columns against each item in the BOQ. In case no rate is quoted against any item, the same will be executed free of cost by the contractor, as per specifications/drawings. Furthermore two decimal digits will be considered for evaluation.
- The firm must be enlisted with Pakistan Engineering Council (PEC) in Category C-5 or above for the year 2015-16 (compulsory).
- The firm must have specialization codes of EE-06 and EE-11 (compulsory).
- The firm must be enlisted with Local Council Board (LCB) for 2015-16 in relevant category (compulsory).
- In Case, if license of a firm/company is expired at 31/Dec/2015, the firm /company should provide guarantee to give a renewed license for the year 2016 before issuing work order.
- Contractor must provide Undertaking/Affidavit in their technical bids stating that they have provided CDR equal to 2% of the Bid Cost. The affidavit must be attached in the technical bid while the CDR will be attached in the Financial Bid (compulsory).
- The Bidder should have completed at least two (02) Solar Road Light Projects with Govt organizations of Rs. 5 Million or above value (Attested copies of work orders and completion certificates must be attached along with technical bid) (compulsory).
- All the material must be procured from renowned and reputable manufacturers and must comply with the specifications / standards / certifications mentioned in the technical criteria.
- The Company / Firm will be bound to ensure full time presence of their Engineer on site for ensuring quality work and all the technical discussion with the supervising staff exclusively for the work awarded to them.
- The competent authority reserves the right to reject any or all the tenders without assigning any reason thereof.
- Any disfiguring / over writing / manipulation in the tender document shall be subjected to rejection.
- Rates in the BOQ must be written both in figures and words. The Contractor should sign all the pages of the BOQ. In case of non-compliance tender shall not be entertained for competition.
- All Federal & Provincial Duties / Taxes including Sales Tax will be recovered as per directives of the Government issued from time to time.
- Incomplete, conditional or telephonic tender shall not be accepted.
- All those contractors whose quoted rates are more than 10% below, will deposit additional security in the shape of call deposit equal to the below percentage of their quoted rate.
- Work order will be issued after the release of fund.
