Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, In-charge Security Department, The Bank of Khyber, Peshawar's Tender Notice for Hiring of Security Agency.

Dear Sir,

This is with reference to The Bank of Khyber, Peshawar's Tender Notice, published in daily "Nawaiwaqt" on 9th August, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, "The Bank of Khyber reserves the right to accept or reject any or all proposals without assigning any reason". It is not complying with KPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
