**Sub: Violation of Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act 2012,
Chief Executive Officer, Water and Sanitation Services Company (WSSC), Abbottabad's
Pre-qualification Notice for Provision of Sanitation Services.**

Dear Sir,

This is with reference to WSSC, Abbottabad's Pre-qualification Notice published in daily "Mashriq" on 9th December, 2017. It is observed that the advertisement is in violation of the KPK PPRA Act 2012.


As per advertisement, the fee of bid/RFP is given as PRs 10,000/-, which appears costly in light of the Procurement Act and is violation of KPK PPRA Act 2012. According to the Act, Section No. 19, in the 'Public Accessibility' Clause, the tender document fee shall not exceed printing cost. Stated as under;

***19. Public Accessibility.** --This Act, the rules made thereunder, guidelines, forms, bidding documents and/or decisions of Government or procuring entity relating to procurement shall be placed on a web-site of the Authority in addition to the website of the procuring entity or the Government, as the case may be, and which will also provide copies of these documents to the public at a fee not exceeding the cost of printing/reproduction of the documents.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.
