
Dear Sir,

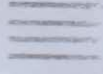

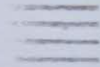
