Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Project Manager Mini-Micro on Canals in KPK, PEDO, Peshawar's Re-Tender Notice to Plan, Designed, Procure and Construct Five (05) Hydropower Project.

Dear Sir,

This is with reference to PEDO, Peshawar's Re-Tender Notice, published in daily "The News" on 10th January, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

Only the date and time of the submission of tender is mentioned in the advertisement, whereas it should also include the date and time of opening of tender that shall be on the same day. It is a violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Pakhtunkhwa Energy Development Organization (PEDO) intends to plan, design, procure and construct Five (05) micro hydropower projects on different canals in Khyber Pakhtunkhwa as pilot projects: the funds for these schemes have been allocated under Annual Development Program. Objective of the projects are to provide cheap electricity to the nearby local community/ school/ BHU etc.
2. In this regard tenders on EPC basis are invited from the interested contractors having valid PEC Registration with JV of NGOs having at least three years successful experience in the planning and development of mini micro hydel projects in KPK to submit their lump sum bid for development of projects on Turn Key/ EPC basis on the terms and conditions given below for following five projects:

3. Terms and Conditions:

Projects will have to be developed on the following terms and conditions:

- i. The project will be built on EPC/ Turn Key basis along with power distribution system and the bidder shall have to bid for all the five sites.
- ii. A two stage single envelope procedure will be adopted and the Bidder will be informed through their respective contacts for opening of Technical and Financial proposal.
- iii. Contractor will be responsible for the appropriate location, feasibility study, designing, procurement, construction including transmission line and successful operation of the project.
- iv. Contractor will be responsible for community mobilization and concluding an agreement with consumers for its operation and maintenance after completion.
- v. Contractor will operate and maintain the power plant for six months after its completion and then handover to community/ school / BHU for its O&M under the agreement;
- vi. The cost of project will be fixed which will be paid in three to four installments and no escalation or extra cost will be paid by PEDO.
- vii. Projects will have to be completed within six (06) months from date of signing of contract agreement.
- viii. The firm will be responsible for supply of spare parts free of cost during defect liability period
- ix. The firm will be responsible for training of locals for the operation and maintenance and collection of revenue.
- x. Contract will be based on PEC Standard Form of Contract; Bid should be accompanied with 2% bid security (Bank guaranty only) and successful bidder will have to submit 10% performance security (Bank guaranty only) as per prevailing rules of KPK.
- xi. The above mentioned sites locations/capacity may be changed if required.
- xii. Further details / information project briefs can be obtained from PEDO Head Office during working hours.
