Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, TMO/ Tehsil Officer (I&S), Tehsil Municipal Administration (TMA), District Haripur's E-Bidding Notice for Provision of items and Miscellaneous Works.

This is with reference to TMA, District Haripur's E-Bidding Notice, published in daily "The News" on 12th December, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of tenders is on 17-12-2018, which is 9 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the E-Bidding notice under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Registration of the contractor should be renewed from Local Government Elections & Rural Development Department (LCB) Khyber Pakhtunkhwa for the year 2018-2019. Copies of CNIC, National Income Tax certificate and his registration must be attached with tender documents.
- The original/ duplicate copy of sealed tender documents will be submitted to this office and tender documents must be reached upto the fixed dated and time mentioned above as per letter no CE/LCB/1-1/2016 dated 23-08-2016 was issued by the Chief Engineer LCB Khyber Pkhtunkhwa.
- Any contractor/firm are bound to mention the rates as per notification No KPPRAM&E/Est: 1-5/2016 "Above/Below System".
- The contractors / bidders who offer / Quote their bids / rates more than 10% below the Engineer's Estimate shall submit an additional security in the form of call deposit equal to 6% of the estimated cost. After commencement of work by the successful bidder 6% call deposit may be replaced with a bank guarantee of the same amount from the schedule bank.
- The downloaded BOQ & call deposit must be attached along with tender form, if any negligence from the contractor in this matter, the department can debar such contractor from E-Tendering system.
- In case bids become tie, the award of contract shall be decided through a free toss which shall be binding and final.
- As per Provincial Government all the bidders /firms must to be registered with Khyber Pakhtunkhwa Revenue Authority established under the Khyber Pakhtunkhwa Finance Act,2013 (Khyber Pakhtunkhwa Act No.100 of 2013).
- All Federal and Provincial duties /stamp duty and taxes including sales tax will be recoverable as per directives of the Government issued from time to time.
- The work order of Developmental schemes to be issued on the availability of funds.
- Other terms and conditions can be obtained in office working hours or from web site mentioned above.
