Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director General(Extension), Livestock and Dairy Development Department, Peshawar's Pre-qualification Notice for Veterinary Medicines.

Dear Sir,

This is with reference to Livestock and Dairy Development Department (Extension), Peshawar's Pre-qualification Tender Notice, published in daily "Aaj" on 10th June, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission of tenders is on 19-06-2017, which is 5 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

***13. Response time.** - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

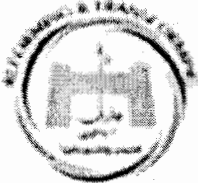
