Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Secretary/Nazim, Village Council Drima Khel, Bannu's E-Tender Notice for Constructions and Installation Works.

Dear Sir,

This is with reference to Village Council Drima Khel, Bannu's E-Tender Notice, published in daily "Aaj" on 11th June, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission of tender is given as 21-06-2017, which is 4 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

TERMS & CONDITIONS

- Tender form/BOQ can downloaded by the original contractor available on LG&RDD web site (www.lgkp.gov.pk)
- The sealed tenders should reach to the office of the concerned Council as mentioned above on or before the opening date/time given against each work.
- The tender documents should be complete in all respect and incomplete documents will not be acceptable for consideration.
- The following document are required to be submitted with the application/tender form:
 - Earnest money to the extent of 2% in the shape of deposit at call in the name of Village Council Nazim along with stamp duty.
 - Enlistment copy and renewal with LG&RDD for the current year.
 - CNIC copy of the bidder.
 - Copy of registration and renewal of Pakistan Engineering Council for the current year.
- Bidders found with bogus documents, their tenders will be rejected and their cases will also be forwarded to higher ups for black listing.
- The contractors/firms will have to start work immediately (within one week), after the issuance of work orders, otherwise their call deposits will be forfeited and they will not be allowed to participate in any tendering process.
- The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring entity shall upon request communicate to any contractor or consultant who submitted a bid or proposal, the ground for rejection of all bids or proposals as per KPPRA Rules.
- All the government taxes will be deducted as per prevailing government policy.
- The item rates system is replaced by above/below system on BOQ Based on MRS-2016.
- Any cutting/overwriting on the BOQ will be liable to rejection of the tender and will be declared defective.
- Tenders/bids should reach to the office of the Concerned Council as mentioned above through courier/registered post before the opening time.
- Responsibility of late delivery will not rest upon this office.
- original Tender documents should reach to the concerned office of Village Council Nazim and Duplicate Form shall reach to the office of the Assistant Director LG & RDD Bannu before closing date & Time of the Tender.
- Any addition made in Terms and conditions in the NIT advertised in the news paper will be implemented as per KPPRA Rules / Govt. Policies
- The Contractors/Bidders who quote their bids/rates more than 10% below the Engineers Estimate shall submit an additional Security in the form of call deposit equal to 8% of the bid cost.
- If the performance bond and Bank Guarantee (whichever the case may be) is not provided by the bidder in the required period, then offer will be given to the next lowest bidder and so on and the bidder security defaulter bidder will be forfeited.
- All other terms/conditions/documents can be seen in the office of undersigned on any working day during office hours.
- The Cost Estimate of the works are prepared on MRS 2016. Contractor should quote their notes in figures as well as in words and only 1st two figures after decimal of the rates will be considered during evaluation of the bids.
