Subject: **VIOLATION OF KHYBER PUKHTUNKHWA PUBLIC PROCUREMENT REGULATORY AUTHORITY ACT 2012, TMO, TMA DIR TENDER NOTICE FOR DRINKING WATER SUPPLY.**

Kindly refer to letter No. TL15/1011/3A, dated 10/11/2015 on the subject cited above.

It is submitted for your kind information that this office has issued electronic tender notice for the development scheme "Water Supply & Sanitation Programme For Bibyawarr & Darorra ADP # 754/150499" for the open competitive bidding of the registered contractors/ companies registered with the Pakistan Engineering Council & Local Council Board, Khyber Pukhtunkhwa.

Furthermore the prescribed tender form fee has been charged from the contractors at the ratio of 0.05% of the total cost of Rs. 49.95 Million as per notification No. SOG/C&W/11-129/Contractors/Vol-IV/2010, dated 05/01/2012, while downloading tender forms from the Local Government website www.lgkp.gov.pk, the form fee is automatically inscribed on the form.

Secondly as per clause # 5 of the advertisement notice the contractors directly deposited the prescribed fee in the Government/ TMA Dir account#1722, Bank of Khyber Dir Branch and receipt thereof is attached with the bidding documents.

The above notification is still valid and applicable in the Local Government Department Khyber Pukhtunkhwa and the tender form fee is part of budget of TMA's.

It is therefore requested that the Local Government Department, Khyber Pukhtunkhwa may kindly be directed to abolish the tender form fee through notification to avoid audit objection in future.

Moreover, the directions of your goodself are noted for ensuring transparency in the interest of government/ public.
