Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director Culture, Directorate of Culture Khyber Pakhtunkhwa, Peshawar's Call for Proposals Notice for Various Cultural Activities.

Dear Sir,

This is with reference to Directorate of Culture, Peshawar's Call for Proposals Notice, published in daily "The News" on 9<sup>th</sup> October, 2016. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per the advertisement, the submission of proposals is given as 24-10-2016 while the opening of technical proposals is kept on 27-10-2016. Therefore the advertisement is in violation of KPPRA Rules 2014, Rule No.37 (6). Stated as under;

*37. Submission of bids and bid opening: — (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the Call for Proposals under the prescribed procedures or issue a corrigendum and extend date accordingly.
