Dear Sir,

This is with reference to Paraplegic Center, Hayatabad, Peshawar's Tender Notice, published in daily "Aaj" on 13th April, 2016. It is observed that the advertisement is in violation of KPK PPRA Act 2012.

As per the advertisement, Paraplegic Center, Hayatabad, Peshawar has restricted the bidders to supply 'Laptop' of HP only, and has not added "**or equivalent**" with it, which is not allowed under KPK PPRA Act 2012, Section No. 23 (4). Stated as under;

23. Bid Solicitation documents -- (4) Each procuring entity shall solicit bids based on performance or functional specifications and not on restrictive or proprietary specifications of a particular brand.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
