Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Assistant Director/ Sub Engineer, LG & RDD, Secretaries/ Nazimeens, Village Council/ Neighborhood, Peshawar's E-Tender Notice for Miscellaneous Construction Works.

Dear Sir,

This is with reference to LG & RDD and Village Council/ Neighborhood, Peshawar's E-Tender Notice, published in daily "Aaj" on 12th June, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission of tenders for works under S.r No. 1-5 is on 19-06-2017 which is 7 days short, and for works under S.r No. 6-12 is on 20-06-2017 which is 6 days short. It is a violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under;

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Tender forms will be received till 12.00 pm and opening of tender will be at 2.00 pm at Office of Assistant Director Bacha Khan Chowk or Parida Bagh near Shahi Bagh, Peshawar. The completion period will be as per work order.
- The following shall be attached with the bids: (i) Enrollment and Renewal Copy in LG & RDD Department for the current year; (ii) Photocopy of CNIC (if applicable); (iii) Power of Attorney (if applicable).
- The 2% Earnest Money (paid) against each work and additional security shall be received in the shape of Call Deposit / Bank Guaranty from scheduled bank in the name of concerned Nazim only.
- Tender documents of bidders if found with bogus / false documents will be rejected and their registration shall stand cancelled / suspended in addition of forfeiture of earnest money.
- Incomplete bids without 2% earnest money shall not be accepted.
- Cutting/Over writing in the BOQ/Contract will be termed as defective.
- The contractors / forms will have to start work immediately (within one week), after the issuance of work orders, otherwise their call deposits will be forfeited and they will not be allowed to participate in any tendering process. More over penalty will be imposed as per the contract agreement in case of contractor failing to complete the scheme in the stipulated time.
- All pages of the bid / tender documents shall be initialed and official seal be affixed by the person or persons signing the bid.
- The contractor shall deposit 8% Additional Security with the tender forms in case of quoting rate more than 10% below otherwise the bid / tender will be consider as defective.
