Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Treasurer, University of Peshawar, Peshawar's Tender Notice for Liveries of Chowkidars.

Dear Sir,

This is with reference to University of Peshawar, Peshawar's Tender Notice published in daily "Mashriq" on 9th December, 2015. It is observed that the advertisement is in violation of the Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014.

There is an ambiguity in the advertisement, pertaining to the opening date of the tender which is 18-12-2015, whereas the date for the receiving of bids is 28-12-15, which is incorrect. It is a violation of KPPRA Rules 2014, Page 18 & 19, 'Submission of bids and bid opening'. Stated as under;

Submission of bids and bid opening.--(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

The above information is forwarded for the purpose of avoiding the mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.-- Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
