Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Medical Superintendent, Women & Children Hospital, Karak's Tender Notice for Procuring High Quality Bio-Medical Equipment.

Dear Sir,

This is with reference to Women & Children Hospital, Karak's Tender Notice published in daily "Mashriq" on 13th January, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, "Quantity of items can be increased/ decreased", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, Rule No.10. repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:
(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:
(i) repeat orders within a period of six months:
Provided that it does not exceed fifteen percent of the original contract value;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- 4 A pre-Bid meeting will be held on 30th January 2016, 11.00 hours at the address given below. The Bidders are requested to thoroughly study the Standard Bidding Documents before the pre-Bid meeting for any clarification of their queries during the said meeting.
- 5 Bids must be delivered at the address given at or before 11.00 hours on 6th Feb-2016 and shall be opened in the presence of the Bidders or their authorized representatives, who choose to attend at the address below at 11:30 hours on the same date.
- 6 Firms which are registered or pre-qualified, shall submit the Bid security in an envelope along with the financial Bid in the shape of Pay order (PO), demand draft (DD) call deposit Receipt (CDR) equal to 2% of their bid amount and the firms which are not registered or pre-qualified with the DGHS, KPK shall submit Bid security equal to 5% of their bid amount in the name of the Medical Superintendent Women & Children Hospital Karak. The bidders shall submit an under-taking in their technical bids that the requisite bid security is included in their financial bid. If the bids will be treated as non-responsive.
- 7 The Bidders are requested to give their best and final price for the quoted equipment as per the specifications in part-two: section-iv of the standard bidding Documents as no negotiations on the price are allowed. The bid must be valid up to 30.06.2016. Quantity of items can be Increased/decreased.

Note:- The Competent authority has the right to reject any or all bids by assigning reason under Rule-32 of the Khyber Pakhtunkhwa, Procurements of Goods, works & services rules 2014.
