**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services  
Rules 2014, Secretary, Board of Intermediate & Secondary Education, Kohat's Tender  
Notice for Hiring Security Services.**

Dear Sir,

This is with reference to BISE, Kohat's Tender Notice published in daily "Express" on 11<sup>th</sup> January, 2018. It is observed that the advertisement is in violation of the KPPRA Rules 2014.


As per advertisement, "The number of supervisor and security guards can be increase/decreased as per requirements of BISE Kohat", whereas any change in tender conditions, specifications and quantity after bid opening by procuring agency is not allowed under Rules. However, according to KPPRA Rules 2014, Rule No.10, repeat orders cannot exceed more than 15% of the original quantity. Stated as under;

*10. Alternate methods for procurement of goods.--- A procurement entity may use the following alternative methods for procurement of goods, namely:  
(c) a procurement entity shall only engage in alternate method if the following conditions exist, namely:  
(i) repeat orders within a period of six months:  
Provided that it does not exceed fifteen percent of the original contract value;*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

1. Security Supervisor -12 hours
2. Security Guards -12 hours

The last date for its submission is 25<sup>th</sup> of January, 2018 at 10:00am. The tenders thus received will be opened on the same day (25<sup>th</sup> of January) by the concerned committee of BISE Kohat in the presence of the participants/their representatives (if any) at 11:00 AM. Prescribed Tender Form can be obtained from the office of the undersigned during office hours on payment of Rs. 500/- (non-refundable). Sealed Tenders, complete in all respects & fulfilling the following conditions should reach the office of the undersigned within the stipulated period.

1. Tenders /Applications must be accompanied with a call deposit (tender security) of at least 5% of the estimated cost in shape of CDR, bank Draft, Or pay Order, to be deposited in favor of Secretary BISE Kohat, without which the offer shall be rejected as being non-responsive.
2. Initially, the contract will be for the period of (01) year which can be renewed on yearly basis for further 02 terms at the discretion of BISE Kohat subject to performance.
3. The bidders must have valid licenses from Ministry of Interior & Govt of Home Department of respective provinces.
4. Matters regarding all kind of tax deduction (Income tax/sales tax etc.) will be dealt as per the prevalent government rules.
5. Attested copies of CNIC/Registration/Income tax certificates along with GST/NTN must be attached with the tender form.
6. No tender/application will be accepted after the expiry of the stipulated time and date.
7. The firm should not stipulate any condition while offering tenders. Such tenders would be liable to rejection out rightly.
8. An affidavit that company has never been blacklisted by any Govt/Semi/Autonomous body in any province must be attached.
9. BISE Kohat reserves the right to accept or reject any or all the applicants assigning with cogent reasons.
10. BISE Kohat does not bind itself to accept the lowest or any offer & assign reason for it.
11. The number of supervisor and security guards can be increased /decreased as per requirements of BISE Kohat.
12. The skills/experience/backgrounds of the Armed Security Guards required are as under:
  - a. Retired Armed Forces Personnel.
  - b. Age below 50 years.
  - c. Security Wise cleared by police.
  - d. Healthy Medically Category "A"
  - e. Able to read and write.
  - f. Armed with latest weapons preferably Kalashinkove.
