Sub: Violation of Khyber Pakhtunkhwa Public Procurement Regulatory Authority Act 2012 & Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Project Director, Khalifa Gul Nawaz Medical Complex, Bannu's Tender Notice for Purchase of Items.

Dear Sir,

This is with reference to Khalifa Gul Nawaz Medical Complex, Bannu's Tender Notice, published in daily "Express" on 10th May, 2018. It is observed that the advertisement is in violation of the KPK PPRA Act 2012 and KPPPRA Rules 2014.

1. As per the advertisement, Khalifa Gul Nawaz Medical Complex, Bannu has restricted the bidders to supply Laptop of 'Dell' brand only, and has not added "**or equivalent**" with it, which is not allowed under KPK PPRA Act 2012, Section No. 23 (4). Stated as under;

23. Bid Solicitation documents --- (4) Each procuring entity shall solicit bids based on performance or functional specifications and not on restrictive or proprietary specifications of a particular brand.

2. Also, it is mentioned that tenders should reach within 15 days of the advertisement, which makes it is 24-05-2018, while the tender opening is kept on 30-05-2018. Therefore, the advertisement is in violation of KPPPRA Rules 2014, Rule No.37 (6). Stated as under;

37. Submission of bids and bid opening: --- (6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.

3. Also, Khalifa Gul Nawaz Medical Complex, Bannu will have the right to reject any tender without assigning any reasons". It is not complying with KPPPRA Rules 2014, Rule No.47 (1), which requires that reason should be communicated to bidders. Stated as under;

47. Rejection of bids: - (1) The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring agency shall upon request communicate to any supplier or contractor who submitted a bid or proposal, the grounds for its rejection of all bids or proposals, but is not required to justify those grounds.



The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
