**SUBJECT: CORRUPTION IN BOARD OF INTERMEDIATE & SECONDARY EDUCATION  
PESHAWAR BY THE CONTROLLER MR. MALIK MAQSOOD ANWAR**

Respected Sir,

We would like to bring your kind attention toward corruption in conduct of examinations and preparation of results by **Mr. Malik Maqsood Anwar** Controller of Examination Board of Intermediate & Secondary Education Peshawar. Sir, the following facts can be easily verified from the Board's record:-

- a) **Corruption in purchase of answer books:** Despite the decision of the Board of Governor (BoG) of BISE Peshawar regarding purchase of Answer Books through open tender for the year 2017-18 & 2018-19, the above named Controller illegally purchased answer books without any tender for kickback of **two crore rupees from owner of Zar Pana Printing press.**
- b) **Sale of Exam Centers:-** Despite of the written direction from Govt of Khyber Pakhtunkhwa and Chairman BISE Peshawar regarding strictly observance of computerize draw for deputing supervisory staff, of the named controller of examination had deputed supervisory staff on choice to the private institutions and received kickbacks from private institution. One glaring example is Haadaf group of colleges etc. In return of kickbacks some teachers were also illegally appointed to those exam centers wherein, their own children were giving the board exams, which is a serious crime and against the board's Act.
- c) **Passing of absent candidates:** Those candidate who were absent in practical of the science subjects have been awarded marks and passed by the Controller of Examination for kickbacks.
- d) **Tampering in award list (marks):** A post result validation committee was constituted by the chairman to verify that whither any unlawful charges were made in the results, the committee in its report reveal that marks of several candidates have been unlawfully increased by the controller of examination by unlawfully tampering in award lists. Two evidences are Roll Numbers 72647 & 141545 SSC (Annual) Examination 2019.
- e) **Solving of papers at secrecy:** In case of fictitious Roll No. 134488 (SSC-Part-II) 2019 two question were written in the answer book after the result declaration on the behest of the controller for kickbacks.

It is therefore requested that a high level inquiry may be conducted in the case and he may be removed from the service in best interest of the organization. We have not mentioned our names and addresses due to any future mishap.
