Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Director General, Small Dams Directorate, Irrigation Division, Hayatabad, Peshawar's Pre-Qualification Notice for Construction of Dam.

Dear Sir,

This is with reference to Small Dams Directorate, Irrigation Division, Hayatabad, Peshawar's Pre-qualification Notice published in daily "Dawn" on 14th December, 2017. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of proposals is on 25-12-2017, which is 3 days short. It is a violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the Pre-qualification under the prescribed procedures or issue a corrigendum and extend date accordingly.

All the necessary instructions regarding experience, Personnel capabilities, Equipment capabilities, Financial position or any other information to the Pre-qualification are mentioned in the pre-qualification criteria guidelines which must be read carefully by the candidate applying for the pre-qualification and the requisite information shall properly be submitted in the binded form duly page numbered and shall reach to the office of the undersigned within the prescribed period. Those Contractors/Firms who are already pre-qualified with the Directorate General Small Dams Peshawar shall also re-apply for the pre-qualification on the prescribed criteria guidelines.

The pre-qualification guidelines/ Application Form may be obtained from the office of the undersigned for each project separately on cash payment of Rs.1000/- (Non-refundable) up to 25/12/2017 on any working day. The clarification meeting will be held on 28/12/2017 at 10.30 Hrs. in the office of the undersigned where all prospective applicants may request clarification about the pre-qualification process criteria or any other information or question about the evaluation process.
