Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services  
Rules 2014, Executive Engineer, Provincial Buildings (Construction) Division No.I, Peshawar's  
EOI Notice for Establishment of Mobile Courts in KPK.

Dear Sir,

This is with reference to Provincial Buildings (Construction) Division No.I, Peshawar's EOI Notice, published in daily "Mashriq" on 12<sup>th</sup> February, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, the Scope of Work/ TORs can be obtained at least Five days before the closing date, i.e, till 20<sup>th</sup> February, 2016, which means bidding documents are not available for the bidders till the submission date, i.e, 25<sup>th</sup> February, 2016. The rule "Response Time" includes purchase of bidding documents for the bidder from the date of publishing of advertisement till the date of submission of bids. Therefore, the advertisement is in violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

*34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the EOI under the prescribed procedures or issue a corrigendum and extend date accordingly.
