Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Secretary/ Nazim, Village Council 177, Sheikhan Bala, Peshawar's E-Tender Notice for Construction of Street, Drains, Side Walls, Sanitation etc.

Dear Sir,

This is with reference to Village Council 177, Sheikhan Bala, Peshawar's E-Tender Notice, published in daily "Aaj" on 15th June, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per advertisement, 15 days of response time is not given and the last date for the submission of tenders is on 23-06-2017, which is 6 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

All the tender/ bidding shall be done on "Percentage Below/ Above". (3). The following shall be attached with the bids: (i). Enlistment and Renewal Copy in LGE&RDD Department for the year 2016-17. (ii). Photocopy of CNIC. (iii). Power of Attorney (if applicable). (4). The 2% Earnest Money as mentioned against each work, shall be received in the shape of Call Deposit from scheduled bank in the name of concerned Nazim. (5) Tender documents of bidders if found with bogus/ false documents will be rejected and their registration shall stand cancelled/ Black listed in addition of forfeiture of earnest money. (6). Incomplete bids or without 2% earnest money shall not be accepted. (7). Cutting/ Overwriting in the BOQ/ Contract will be termed as defective. (8). The limits for below rates shall be followed as per Government Rules. (9). The contractors/ firms will have to start work immediately (within one week), after the issuance of work orders, otherwise their call deposit will be forfeited and they will not be allowed to participate in any tendering process. (10). All pages of the bid/ tender documents shall be initiated and official seal be affixed by the person or persons signing the bid. (11).
