

1. Tender from can be downloaded from the date of appearance of the advertisement in the leading newspapers next day from the official website of LG&RDD, (LCB) Khyber Pakhtunkhwa, ([www.lgkp.gov.pk](http://www.lgkp.gov.pk)).
2. Attested photocopy of the requisite documents like Enlistment, Pakistan Engineering Council Registration, and income Tax Certificate etc, must be attached with the application (Original documents will be produced for confirmation on demand)
3. The firm must have specialization code of EE-06 (Compulsory).
4. The bidders should have completed at least 02 two numbers of Road Lights (Electric Lights) Projects with Government Organizations of Rs.5.000 Millions or above value (Attested copies of Work Order and Completion Certificates must be attached along with Technical Bid (Compulsory)).
5. The sealed tenders should reach to the office of undersigned on Dated: 15-06-2017, timing 12:00 a.m. Responsibility of late delivery will not rest upon this office. The tenders will be opened on the same day at 2:00 p.m.
6. The tender documents should be completed in all respect and incomplete documents will not be acceptable for consideration.
7. The following document are required to be submitted with the application/tender form:-
  - I. Earnest money to the extent of 2% in the shape of call deposit in the name of TMO Khwazakhela, along with stamp duty.
  - II. Enlistment copy and renewal with Khyber Pakhtunkhwa, Local Council Board, for the current year.
  - III. CNIC copy of the Bidder.
  - IV. Copy of registration and renewal of Pakistan Engineering Council for the current year (EE 06).

- V. The contractors applying for this work must be enlisted with the Electric Inspectorate, Khyber Pakhtunkhwa and must attach a copy of enlistment certificate.
8. Bidders found with bogus documents, their tenders will be rejected and their cases will also be forwarded to higher-ups for black listing.
  9. The Contractors/Firms will have to start work immediately (within one week), after the issuance of work orders, otherwise their call deposits will be forfeited and they will not be allowed to participate in any tendering process.
  10. The procuring entity may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The procuring entity shall upon request communicate to any contractor or consultant who submitted a bid or proposal, the ground for rejection of all bids or proposals.
  11. All the Government Taxes will be deducted as per prevailing Government Policy.
  12. The bidders will have to quote rate on above /below basis.
  13. Any cutting/overwriting on the BOQ will be liable to rejection of the tender and will be declared defective.
  14. Tenders/ Bids should reach the office of the undersigned through courier/registered post.
  15. Any addition made to the Terms and Conditions of the NIT advertised in the newspaper will be implemented as per KPPRA Rules.
  16. The Contractors/ Bidders who quote their bids/rates more than 10% below the Engineer's Estimate shall submit an additional security in the form of call deposit equal to 8% of the bid cost. After commencement of work by the successful bidders 8% call deposit may be replaced with the bank guarantee of the same amount from the scheduled bank.
  17. If the performance bond or Bank Guarantee (which ever the case may be ) is not provided by the bidder in the required period, then offer will be given to the next lowest bidder and so on arid, the bid security defaulter bidder will be forfeited.
  18. Bids will be valid for 90 days.
