



Kindly refer your office letter No. DS (T)/Policy/1-Vol-I/2013/C&WD dated 10/09/2015 regarding the violation of Khyber Pakhtunhwa public procurement of goods, works and services rule 2014 in the Request for Proposal (RFP) advertised by this office for the consultancy services of RCC bridges in Dir Lower.

According to Chairman Transparency International Pakistan department letter No. TL15/019/2A dated 01/09/2015, "the date and time of submission of TOR is mentioned in the Request of Proposal (RFP) without stating the date and time of opening of TOR that shall be on the same day".

But actually in the advertisement of Request of Proposal (RFP) for the consultancy services, Executive Engineer give only date and time of submission of technical and financial proposal and he is not authorized to give the date and time of opening of the technical and financial proposal. However this office further submits the sealed envelopes of technical and financial proposal of the consultants to Departmental Consultants Selection Committee (DCSC) forum for its opening and evaluation. So the date and time of opening of technical and financial proposal depends upon the Departmental Consultants Selection Committee meeting.
