Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Secretary/ Nazim, Village Council Tor Lawang Khel, Jabu Khel, District Lakki Marwat's E-Tender Notice for Miscellaneous Construction Works.

Dear Sir,

This is with reference to Village Council Tor Lawang Khel, Jabu Khel, District Lakki Marwat's E-Tender Notice, published in daily "Aaj" on 14th April, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission of technical proposals is given as 25-04-2017, which is 3 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

13. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.
