**Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Municipal Administrator/ Tehsil Officer Infrastructure, Tehsil Municipal Administration (TMA), Tank's Tender Notice for Construction of a Masjid.**

This is with reference to TMA, Tank's Tender Notice, published in daily "Nawaiwaqt" on 14<sup>th</sup> April, 2019. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for the submission/ opening of tenders is given as 25-04-2018, which is 3 days short. It is a violation of KPPRA Rules 2014, Rule No.34 (I). Stated as under:

*34. Response time. - (1) The procuring agency may decide the response time for receipt of bids or proposals (including proposals for pre-qualification) from the date of publication of an advertisement or notice, keeping in view the individual procurement's complexity, availability and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

## TERMS &amp; CONDITIONS

- All the bidding will be through E-bidding system. Tender Form & DOQ's can be filled and downloaded by the original contractor available on the official website of LG&RDD. ([www.lgkpw.gov.pk](http://www.lgkpw.gov.pk)) Khyber Pakhtunkhwa after one day of publishing of NIT in newspaper.
- The contractor is required to fill the tender form and DOQ online and submit a hard copy of the same tender to the office of Tehsil Municipal Administrator TMA, Tank before fixed date and time as mentioned.
- The following documents must be attached with bids:
  - Enlistment and renewal copy in Local Council Board for the year 18-19 (2) Attested Photocopy of NIC
  - Power of Attorney (if applicable).
  - Pakistan Engineering Council (PEC 2018-19).
- Tender documents of bidders if found bogus/false documents will be rejected and their registration shall stand cancelled / black listed in addition of forfeiture of earnest money and security amount (if any).
- No tenders are acceptable through fax/by hand. Scaled bids sent through registered mail/couriers service should reach up to the specified time and date. The contractor or his representative may be present at the time of opening of tender.
- Any contractor/firm are bound to mention rates as per notification No. KPPRA/MA&E/Estt./1-5/2016 "Above/Below system".
- The bidder who offer their bid more than 10% below of the estimate cost will have to enclose additional 5% cash deposit of the estimated cost in original in the name of Tehsil Municipal Administrator TMA, Tank along with tender documents otherwise the bid will not be entertained.
- In the case the bid becomes a tie the contractor shall be decided through a free toss which shall be binding and final.
- The time limit of each work shall be as per work order issued to successful bidder and the contractor will have to start the work within 15 days time period after the issuance of work order failing which the work will be cancelled and security/additional security (if any) will be forfeited.
- All Federal and Provincial duties/stamp duty and taxes including sales tax will be recoverable as per directives of the government issued from time to time.
- The procuring entity may reject any or all bids after communicating the reasons for rejection at any time prior to the award of contract.
- Any addition made in terms & conditions in the NIT advertised in the newspaper will be implemented as per KPPRA Rules.
- The 2% Earnest Money for the work shall be submitted in shape of original online call deposit/GDR in the name of Tehsil Municipal Administrator TMA, Tank.
