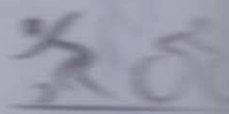



Subject: Tender Notice

I am directed to refer to the subject noted above and to inform you that the following discrepancies have been noticed in your Tender notice advertised in "Daily Aaj" on 10th April, 2019 (Copy Attached) for ready reference.

The response time given for the submission of bids is less than fifteen (15) days which is violation of **Rule 34 (1)**, of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014 (Rules), which states as:

"The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper".

Further, the procuring entity has mentioned **Rule 6(2) (a)** in tender notice which is irrelevant. The relevant Rule for the tender notice is **Rule 14(a)(b)**.

It is pertinent to mention here that as per **section 2(1) (n)** of KPPRA Act, 2012 read in conjunction with **Rule 54**, Public Procurement in contravention to the provisions of this Act or any other law in respect of or relating to public procurement, including any rules, regulations, orders or instructions made in this behalf shall constitute mis-procurement and person responsible for such breach shall liable to be proceeded under the relevant law.

It is therefore, advised to rectify the same (by issuing Addendum/Corrigendum) and also upload NIT, Addendum/Corrigendum on KPPRA website.

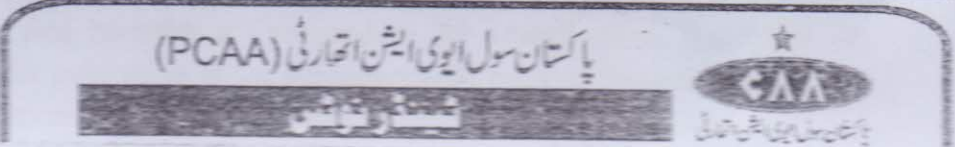
