Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Hospital Director, Medical Teaching Institute, Lady Reading Hospital, Peshawar's Tender Notice for Repair & Maintenance of Record Room.

Dear Sir,

This is with reference to Medical Teaching Institute, Lady Reading Hospital, Peshawar's Tender Notice, published in daily "Dawn" on 11th December, 2015. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per advertisement, 15 days of response time is not given and the last date for submission of bids is given on 22-12-2015, which is 3 days short, and is violation of KPPRA Rules 2014, Page 18, the 'Response time' Clause. Stated as under:

Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement. - Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.

6. Contractors are requested to visit the site before quoting the rates
7. Conditional doubtful, incomplete and without call deposit tender will be rejected. Only fresh call deposit, deposited in Bank of Khyber, Peshawar will be accepted.
8. The Contractor will have to write the rates on tender form in Digits as well as in Words. In case of any cutting or re-writing of tender form, the form will be rejected.
9. The undersigned reserves rights of accepting or rejecting any tender with assigning, reason.
10. Contractors whose tenders are accepted will be liable to pay all government taxes applicable.
11. Other terms and conditions can be confirmed from the office of Assistant Director Works L.R.H Peshawar on any working day. (Saturday is working day)
12. As per Govt. of Khyber Pakhtunkhwa Finance Department No: SO (F.R.) F.d./9-7-2011/vol dated 05-11-2014 further, in lieu of a bank guarantee, an equivalent insurance coverage of a company having at least AA rating from PACRA/JCR shall also be acceptable from Contractors/bidders quoting more than 10% below on engineering estimates/BOQ. These guarantee will be discharged on the expiry of the defect liability period of the contracts within 3 days after opening of the bid, failing which the bid will be canceled and a ready deposited 2% will be forfeited.

14. 1st, 2nd, 3rd lowest bidders call deposit will be retained in this office till approval of the tender.
