Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Secretary, Khyber Pakhtunkhwa Pharmacy Council, Peshawar Cantt's Tender Notice for Procurement of Miscellaneous Items.

Dear Sir,

This is with reference to Khyber Pakhtunkhwa Pharmacy Council, Peshawar Cantt's Tender Notice published in daily "Mashriq" on 14th December, 2016. It is observed that the advertisement is in violation of the KPK PPRA Rules 2014.


As per advertisement, the last date for the submission of tenders is given as 15-12-2016 while the advertisement is published on 14-12-2016, it means 15 days of response time is not given, which is incorrect and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

***34. Response time.---**(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- Firms shall the tender security i.e Rs 25000/- in shape of call deposit/demand draft on the name of Secretary Khyber Pakhtunkhwa Pharmacy Council.
- Late tenders will be treated as non responsive.
- Samples of quoted item should be produce by firms before the selection when asked, in case of failure the tender will not be considered.
- The firm should ensure the supply of items within 15 days otherwise 2% penalty will be imposed on 15 days late supply and 5% on 30 days late supply. Supply will be made at risk and cost of the successful firm.
- The firm should give their best and final price for the quoted items as per specifications as no negotiation on the price are allowed.
