Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services
Rules 2014, Executive Engineer, PBMC Peshawar, C&W Department, Peshawar's Tender
Notice for Miscellaneous Works.

Dear Sir,

This is with reference to PBMC Peshawar, Peshawar's Tender Notice, published in daily "Aaj" on 15th February, 2016. It is observed that the advertisement is in violation of the KPPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for the submission of bids is given as 26-02-2016, which is 3 days short and is violation of KPPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the Tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

 (1) The following documents shall accompany with the Tender Bids:
 a) Photocopy of updated renewal of registration in C&W Department for CFY 2015-16. b) Photocopy of registration with Pakistan Engineering Council valid up to date. c) Photocopy of National Identity Card.
 (2) The documents required for the bid i.e. contractor's brochure showing general experience, particular experience, Accounts statement for 03 years, participating of staff, machinery etc should accompany the Priced BOQ/ Tender form, bid security etc. (3) The person whose name exists in Form H/Partnership Deed will only be entitled to sign the Tender Form, BOQ and all other contract documents. No proxy will be allowed to participate in the bidding. (4) The contractors quoting their rates with his/her own hand writing, computerized filled BOQ will be not acceptable. (5) The 2% Earnest Money and stamp duty shall be received in the shape of Call Deposit from the Scheduled Bank in the name of Executive Engineer Provincial Building Maintenance Cell Peshawar, payable. (6) A complete set of bidding documents may be purchased by interested eligible bidders on submission of written application to the office of undersigned and upon payment of non refundable fee. (7) All the bid must be accompanied by a bid security in the of amount of the 2% of bid and must be delivered to the undersigned before 12 Noon. Bid will be open on 12:30 PM (8) Sealed bids sent through register mail / courier must reach this office before 12:00PM Pakistan Standard Time and Bids will be opened at 12:30 PM on the same date as above in presence of the bidders who choose to attend the opening. Any delay in delivery of tender documents will be the responsibility of the bidders. (9) The bidders are requested to send their bids in duplicate in separate envelopes clearly marked as Original & Duplicate. The original shall be sent to Executive Engineer PBMC C&W, Department Peshawar and the Duplicate to the Superintending Engineer PBMC C&W Department Peshawar (10) All Call deposit will be released after seven days or after verification from bank (11) Tender and copy of Call deposits received through Fax or by hand will not be acceptable.
