Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Deputy Commissioner, Deputy Commissioner Office, Dir Lower's Tender Notice for Hiring of Vehicles.

Dear Sir,

This is with reference to Office of the Deputy Commissioner, Dir Lower's Tender Notice, published in daily "Mashriq" on 15th February, 2016. It is observed that the advertisement is in violation of the KPPRA Rules 2014.

As per the advertisement, 15 days of response time is not given and the last date for the submission of bids is given as 25-02-2016, which is 4 days short and is violation of KPPRA Rules 2014, Rule No.34 (1). Stated as under:

34. Response time.---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the Tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

- (x) C.D.R for amount of Rs.50000/- (Rs.7000 per vehicle) should be attached with Tender.
- (xi) The undersigned has the right to cancel the Tender/Tenders, the reasons of which will be communicated to the concerned bidder/bidders.
