Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Hospital Director, Medical Teaching Institute, Lady Reading Hospital, Peshawar's Tender Notice for the Services of Insecticides Including All Necessary Items.

Dear Sir,

This is with reference to MTI, Lady Reading Hospital, Peshawar's Notice, published in daily "The News" on 13th May, 2017. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.


As per the advertisement, no information regarding issuance of bidding documents is given for the bidders. Therefore, the advertisement is in a violation of KPPRA Rules 2014, Rule No.33 (5). Stated as under;

33. Bid solicitation documents. (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.

The above information is forwarded for the purpose of avoiding mis-procurement charge under Rule No 54, with request to re-invite the tender under the prescribed procedures or issue a corrigendum and extend date accordingly.

Sealed tenders are invited for the year (2017-2018), from the Authorized Dealers for the Service of insecticides including all necessary items in whole hospital of LRH Peshawar inside and outer side of the hospital. Tender should reach to the office of the undersigned through Registered mail/Courier Service on or before 30/05/2017 at 10.00 AM which will be opened on the same day at 10:30 AM in presence of bidders or their representatives. Bid security/earnest money of 2% of the total bid value in the shape of pay order/bank draft/call deposit in (financial bid) is required to be submitted in favor of Hospital Director, Medical Teaching Institution, Lady Reading Hospital Peshawar. The quoted rates should be on F.O.R basis.

TERMS AND CONDITIONS:-

1. The rates approved will remain effective till 30/06/2018.
2. Only typed tender on original prescribing letter pad, sealed & signed (Every Page) should be submitted, hand written tender would not be acceptable. The tenders must be according to hospital specification; alternate rates will not be acceptable.
3. The tender must be submitted along with the call deposit as mentioned above; otherwise the tender will not be acceptable. The CDR must be from the Bank of Khyber, However, this condition will not be mandatory where the Bank of Khyber having no branch in reasonable distance.
4. Sample of the quoted items should be produced by the bidder on the date of purchase committee meeting. In case of failure the bid/tender will not be considered.
5. The bidder will be bound to ensure the supply within 30 days or as early as possible on receipt of order, otherwise the supply will be made on risk and cost of successful bidder.
6. The Income Tax, stamp duty and Professional Tax or any other Government tax will be charged as per rules. However, this hospital is exempted from the General Sales Tax. (Only those firms will be honoured that are on Active Taxpayer's List of FBR).
7. No conditional tender will be acceptable.
8. The successful bidder will be bound to execute agreement on a stamp paper, with 1" order received.
9. If the successful bidder supplies substandard items and not matching with specification issued from this office will be cancelled automatically.
10. Tender giving company must attach the relevant documents along with their tender that should show that their company is authorized dealers of the relevant items
11. Income Tax, Professional tax and all other required documents must be attached with the tender.
12. If the supply is not done within the period mentioned in the supply order, penalty @ 2% will be charged upto 15 days and beyond 15 days the penalty will be charged @ of 5%
13. Bidding will be conducted through single stage –two envelop bidding procedure as per Khyber Pakhtunkhwa Procurement of Goods, works and Services rules.
14. The purchase committee has the right to accept or reject the tender partially or totally and at any stage, after communicating the reason for rejection.
15. The competent Authority has the right to reject all bids under Rule 47 of the Khyber Pakhtunkhwa Public procurement Regulatory Authority (KPPRA) Procurement Rules 2014, after giving valid reason.
