Sub: Request for Re-Tendering by Social Welfare Department, Swabi.

Dear Sir,

Transparency International Pakistan has received a complaint from Mr. Qamar uz Zaman Ch of Plum Qingqi Motors Limited against Social Welfare Department, Swabi dated 14-10-2016 (Copy Enclosed).

The complainant has made following allegations that;

1. The tender was opened on 13.10.16.
2. Two firms were qualified in pre-qualification for auto rickshaw of 28 units that included complainant's firm.
3. Local government administration committee Deputy Commissioner instructions were followed by the committee instead of KPPPRA Rules.
4. Complainant also being a manufacturer, their bid was not considered according to the sample.
5. The Social Welfare Department called for financial bids along with the sample at 10am on first working day after Moharram holidays, which made difficult for firms to move product from Lahore to Swabi in this short notice.
6. Even then complainant's firm arranged financials bids which was refused to be opened by the committee and only local vendor Mardan financial bids were opened.
7. The local agent of Mardan got sample from complainant's dealer showroom and showed the product to bidding committee.
8. The product in the bid was Auto rickshaw but vendor showed motorcycle rickshaw which is entirely different from the specifications.
9. Complainant requested to open their financial bids, and will show their sample within 24 hours if they are the lowest, which was refused.
10. The quoted price was twice that of complainant's retail price.

Chief Minister, Khyber Pakhtunkhwa is requested to kindly examine the complaint and if found genuine take necessary action against all those officers involved in corrupt practices.

Transparency International Pakistan is striving for across the board application of Rule of Law, which is the only way to stop corruption.

Even then we arranged financials but committee opens only local vendor mardan financial our those brand which were not mentioned in the pre qualification (motorcycle rickshaw 100cc instead of auto cab rickshaw 200cc ) and priced double of actual shown product.

We requested to open our financial, if we are lowest we will show our sample within 24 hours but they refused.

Kindly intervene for the best value of the public funds utilization.

The product in the bid was auto rickshaw but vendor has shown motorcycle rickshaw which entirely different from spec. The price even quoted was double of our retail price that shows abnormal price. Kindly inquire from local administration and scrap retender for healthy and open competition in the market.
