Sub: Violation of Khyber Pakhtunkhwa Public Procurement of Goods, Works and Services Rules 2014, Tehsil Nazim/ Tehsil Officer Infrastructure, Tehsil Municipal Administration (TMA), Drugi's Quotation Notice for Miscellaneous Items.

Dear Sir,

This is with reference to Tehsil Municipal Administration (TMA), Drugi's Quotation Notice, published in daily "Aaj" on 14th December, 2015. It is observed that the advertisement is in violation of the KPK Public Procurement of Goods, Works and Services Rules 2014.

1. As per advertisement, no information regarding issuance of bidding documents is given for the bidders. However, according to KPPRA Rules 2014, Page 17, 'Bid solicitation documents' clause, a set of tender document should be provided to the bidders. Stated as under;

***Bid solicitation documents.** (5) Solicitation documents shall be made available to the bidders from the date of their issuance to the closing date on submission of required fee by the prospective bidder whether in person or, if so requested through an authorized request in writing. In case the request is made through courier, it shall accompany a bank draft in favor of the procuring entity including the cost of return delivery.*

2. Also, 15 days of response time is not given and the last date for submission of quotation is given on 23-12-2015, which is 5 days short", and is violation of KPPRA Rules 2014, Page 18, the 'Response time' Clause. Stated as under:

***Response time.**---(1) The procuring entity may decide the response time for receipt of bids or proposals including proposals for pre-qualification from the date of publication of an advertisement or notice, keeping in view the contract's complexity, and urgency. However, under no circumstances the response time shall be less than fifteen days for national competitive bidding and thirty days for international competitive bidding from the date of publication of advertisement or notice in the national newspaper.*

3. Only the date of the submission of quotation is mentioned in the advertisement, whereas it should also include the date and time of opening of quotation that shall be on the same day. It is a violation of KPPRA Rules 2014, Page 18 & 19. Stated as under;

***Submission of bids and bid opening:** — (3) The procuring entity shall issue the bidder with a receipt showing the date and time when the bid was received
(6) All announcements pertaining to public procurement shall specify the last date for submission of bids as well as the public bid opening which shall be the same.*



The above information is forwarded for the purpose of avoiding mis-procurement, mentioned KPPRA Rules 2014, page 22 stated as under; and with request to re-invite the quotation under the prescribed procedures or issue a corrigendum and extend date accordingly.

Mis-procurement.– Any breach of these rules shall amount to mis-procurement and the person responsible for such breach shall be liable to be proceeded under the relevant law.
